

## Paralegal Compressed Program Schedule - Summer 2024

The compressed program is an intense curriculum. All 11 courses are completed throughout the 14 weeks of the program. We expect a student to spend over 40 hours a week outside of the scheduled zoom meetings with several online courses occurring at the same time. Students will need the daytime and evening hours that you aren't meeting in zoom to complete the discussion/assignments assigned week to week while preparing for the midterms and finals for each course.
