

## Paralegal Compressed Program Schedule - Spring 2026

*\*Schedule subject to change.*

The compressed program is an intense curriculum. All 11 courses are completed throughout the quarter. We expect a student to spend over 40 hours a week outside of the scheduled Zoom meetings with several online courses occurring at the same time. Students will need the daytime and evening hours that they aren't meeting in Zoom to complete the discussion/assignments assigned week to week while preparing for the midterms and finals for each course. We **do not recommend** that a student be working or taking other courses during this program. These scheduled dates and times are subject to change. Once the program begins, refer to Canvas for the most updated Zoom dates. Courses that only have a few Zoom meetings will still have weekly discussions and assignments to complete. **All courses are online with required Zoom meetings.**

The program fee is \$8,785 not including the application fee and textbooks. Payment is due by **4:00pm (California time) on Monday, March 23, 2026**. Registration will close once the cohort reaches full capacity. Acceptance into the program does not guarantee a seat – registration is only confirmed once payment has been received. Only students who complete payment and registration before capacity is reached will be enrolled. There will be **no refunds after Friday, April 3, 2026**. Students **cannot to transfer to the part-time format** after starting the full-time, compressed program. Admitted students will receive a textbook list. Textbooks may be purchased from the vendor of the student's choice and in their preferred format (digital or physical). The estimated cost of textbooks is \$600 for digital and \$1550 for physical.
