## **OPT APPLICATION CHECKLIST:**

Complete 3 quarters in certificate level programs.
 (You may use more than one certificate program to complete this requirement)

### WHAT TO PREPARE PRIOR TO YOUR OPT APPOINTMENT:

(REMINDER: PHYSICAL copies of the documents listed below are required for your OPT application packet.)

- <u>Completed</u> Optional Practical Training Request Form (For UCI DCE office use only- do not include with your OPT application to USCIS)
- Completed Form I-765 following the instructions from the OPT Webinar
- Copy of your unofficial transcript (Available by logging into "My Account" at https://ce.uci.edu/)
- Copy of 1st page of <u>ALL</u> certificate level I-20s that have been issued to you, including your current I-20. (Copies of past ESL I-20s are not necessary)
- Copy of valid passport
- □ Copy of F-1 visa
- □ Copy of I-94 arrival/departure record (Find your I-94 record by visiting www.cbp.gov/i94)
- □ TWO (2"x 2") passport type photos (see important notes below)
  - Photos must have been taken within 30 days of your filing your application. Older photos will NOT be accepted by USCIS.
  - Write your first and last name LIGHTLY (in black pen or pencil) on the back of both photos.
- □ Completed Form G-1145 (Optional)
- A check or money order in the amount of \$410 US Dollars, made payable to:

#### U.S. Department of Homeland Security

(You may purchase a money order at a local grocery store)

## AFTER YOUR OPT APPOINTMENT:

- □ TWO Original Copy "OPT Requested" I-20s will be mailed to you
  - You must sign the 1st page of both original copy "OPT Requested" I-20s.
  - You must include one original copy "OPT Requested" I-20 with your OPT application to USCIS.
  - You must keep the 2nd "OPT Requested" I-20 as your valid and updated I-20. It is valid through your OPT period once approved by USCIS.

#### IMPORTANT REMINDERS:

- <u>DO NOT</u> travel outside of the U.S. while your application is in process. Please contact an International Student Advisor before you make any travel arrangements.
- You must apply for OPT at the beginning of your final quarter. You cannot apply for OPT after you have finished your studies.
